

AFFIDAVIT

admission in your college in 1st Year of MD/MS course in the subject _____
for the session 2021-2022 hereby undertake & declare as follows :

1. That I shall abide by the rules and regulations of the college and hostel, failing which I am likely to be debarred from the attending the Classes.
2. That during the academic session, I shall try to attend all the lectures, clinics, tutorials, practical and other prescribed curricular & co-curricular activities so that my attendance shall remain 100%. I also understand that as per NMC rules, 75% attendance in each subject is compulsory to make me eligible to appear in College/University Examination. I also understand that Medical leave does not allow relaxation in attendance (as per NMC Guidelines).
3. That failing the attendance requirement, I shall not be permitted to appear in the college examination and University examination. I shall not lodge any complaint before any authority or court against any action taken by the college in this regard.
4. That I shall keep my parents informed regarding my monthly attendance and academic performance from time to time.
5. That in case of withdrawal from the course, I shall not claim any refund of fee.
6. That as per the Hon'ble Supreme Court Directives, I am aware that if I leave the college/course after taking admission, I have to deposit balance course fee for remaining year/years of the course.

7. That if I am found guilty of keeping Arms & Ammunition, Vehicle, Smoking, Chewing Tobacco/Gutkha, Drinking Liquor or any other intoxicants in the college or hostel campus the decision of the college authority punishing me in any manner will be final and binding to me.

8. That I will pay the fee for each session upto 31st July every year. In case of late payment upto one month i.e. upto 31st August, I will pay a penalty as per college norms. If I fail to deposit the fee upto 31st August, I will also pay the interest @ 15% per annum on outstanding amount in addition to the penalty.
9. During the period when fee is not deposited I shall be liable to be stopped from attending classes/tutorial/practical etc in addition to the fine imposed on me.
10. I understand that I have to pay University Examination fee one month prior to the University Supplementary Examination.
11. That I am not having/hiding any disease/illness already diagnosed or under treatment and if found to do so in my course of studies, I shall be responsible for any penalty or consequence there of, which may amount to cancellation of my seat in the college.
12. Any rules/regulations which may be imposed by College/Government/University in future will be applicable and binding on me.
13. Late fee charges, damage to college/hospital/hostel property will be paid by me. If I fail to deposit the same, may be deducted from my security deposit.
14. If at any stage during my studies any documents or information and Identity/Thumb Impression is found to be incorrect, my admission will stand cancelled and all the dues paid/deposited by me shall be forfeited and I have to pay the full course fee also.
15. That under clause 3 of UGC Regulations 2009 on Curbing the menace of Ragging, I understand the meaning of ragging and I will not indulge in ragging.
16. That I hereby affirm that, if I am found guilty of ragging, I am liable for punishment according to clause 9.1 of UGC Regulations 2009 on Curbing the menace of Ragging, without prejudice to any other criminal action that may be taken against me under any penal of law or any law for the time being in force.
